**MEMBERSHIP CATEGORIES [ARTICLE II, SECTION 2.01]**

***FULL MEMBER:***

The eligibility criteria:

- An Australian citizen or permanent resident of Bangladeshi national or of Bangladeshi descendant living in South Australia.
- An Associate Member of Bangladeshi national or Bangladeshi descendant who has been a member of this Association for a minimum period of one year irrespective of his/her Australian residency status.
- Spouse of a Full Member irrespective of national origin.
- An exception to rule 1 for the full membership category may be made for a Bangladeshi national or Bangladeshi descendant, who has been living in SA for a minimum of one year at the inception of the association on the 11<sup>th</sup> of January, 2004.

***ASSOCIATE MEMBER:***

The eligibility criteria:

- Any person of Bangladeshi national or Bangladeshi descendant who is not an Australian citizen or permanent resident.
- Spouse of an Associate Member.

***HONORARY MEMBER***

Honorary membership can be awarded for any period of time by the General Members body based to the following category of Australians.

- Any person or organization for outstanding contribution to the Bangladeshi community.
- Any Australian citizen who is not of Bangladeshi national or Bangladeshi descendant interested in Bangladeshi culture.

**IMPORTANT MEMBERSHIP NOTES [ARTICLE II, SECTION 2.02]**

- Renewal of membership fees must be paid by the 30<sup>th</sup> September to become an eligible voter in the Annual General Meeting held in the month of June every year.
- New members joining the Association on or before the 31<sup>st</sup> May shall be deemed as an eligible voter in the Annual General Meeting held in the month of June every year.
- New members may request for a full refund if he/she withdraws his/her membership application within two weeks of joining the Association. No refund shall be made if withdrawn membership after two weeks of joining the Association.

- New member joining the Association in the first and the second quarter of a financial year shall pay full scheduled full fee of the membership category.
- New member joining the Association in the third quarter of a financial year shall only pay half of the scheduled full fee of the membership category.
- New members joining the Association in the last quarter of a financial year shall pay full fees of the membership category applied for. Such membership shall be deemed valid until the end of the following financial year.
